Official: Teachers OK with confidentiality agreement

HUNTINGTON — A lawsuit with the goal of forcing the Marshall University administration to comply with Freedom of Information Act requests from two of its professors has been dismissed after a settlement was reached.

The lawsuit was dismissed without prejudice this month by Cabell Circuit Judge David Pancake. Matt Turner, Marshall's chief of staff, said an agreement was reached between the school and the two professors who were behind the lawsuit, finance professor Dallas Brozik and education pro-

Lose the Training Wheels Camp at Huntington High School. The camp is host-

ed by Marshall University Kinesiology along with the non-profit charity iCan Shine. The goal of the camp is to teach participants with disabilities how to independently ride a two-wheel bicycle.

Participants in the camp attend one 75-minute session each day of the camp, which ends Friday, July 19, during which they are trained on specially adapted bicycles.

iCan Shine is a national organization that works with local groups to host camps in individual communities. The Lose the Training Wheels Camp has a success rate of about 80 percent, according to a press release from Marshall University.

in circuit court on June 7 in an attempt to force university administrators to comply with the multiple

FOIA requests the men Sottile filed in May.

In the lawsuit, the men said the university quoted them a price of \$55,000 for Brozik's initial request of five year's worth of information and \$32,000 for three year's worth. Sottile made a similar request, asking for "expenditures by the department/division level for all the colleges, the administration, and the athletic department for the last five years."

Turner said legal representatives for both parties met in June and came to an agreement in which Brozik and Sotille could access the information they requested as long as they signed a confidentiality agreement.

Turner said the men signed the agreement on July 1, but they have yet to formally submit a new request under that agreement.

Under that agreement, the professors can share the information they would have obtained through their FOIA requests with

Ohio sex offender sentenced to 51 years with no parole eligibility

IRONTON - An Ironton man has been sentenced to more than 50 years in prison on sexu-

ally related charges involving a minor, Lawrence Ironton man pleads County Prosecuting Attorguilty to escape ney Brigham M. Anderson said Wednesday.

Jeremy S. Curry, 23, of the 1300 block of South 1st Street, Ironton, pleaded guilty to rape and five counts of pandering sexually oriented matter involving a minor.

Lawrence County Common Pleas Judge D. Scott Bowling sentenced Curry to 11 years in prison for rape and 8 years on each pandering charge. He ordered all sentences to be served consecutively rather than at the same time.

The victim in the rape case was a 2-year-old child, Anderson said. Ohio law provides that the charge could have carried a life sentence in prison due to the age of the victim, he said.

The pandering charges were filed after child pornography was found on the defendant's phone, Anderson said.

"There is no parole eligibility in the case," Anderson said. Curry will have to serve 51 years before becoming eligible for release.

Curry also was found to be a sexually oriented offender/child victim offender and was ordered to report his address to law enforcement for the rest of his life.
